

## **GUIDELINES FOR GREENSBORO ASSOCIATION GRANTS**

- 1) It is the purpose of the Greensboro Association to promote matters of mutual interest to the residents of the Greensboro community. The Association encourages grant requests for specific projects but will consider those for regular operating expenses if they demonstrate unusual worthiness. Applicants are cautioned against dependence on recurring grants.
- 2) All applications will be reviewed against criteria that reflect both the long term mission and shorter term goals of the Association.
- 3) Preference will be given to organizations holding 501(c)(3) status with the Internal Revenue Service.
- 4) All applications for grants shall be submitted either electronically (e-mail: [grants@greensboroassociation.org](mailto:grants@greensboroassociation.org), subject line: GA Grant Request) or hardcopy by mail (Greensboro Association, P.O. Box 59, Greensboro, VT 05841) no later than June 1<sup>st</sup> of each year.
- 5) Grant applications must be completed in full to be considered for funding.
- 6) Only under the most unusual circumstances will grants below \$300 or in excess of \$1,000 be considered.
- 7) If your organization has received funding from the Greensboro Association in the past year, please complete the follow-up evaluation form on page 3 of this application, stating how the funds were used.
