Revised Greensboro Zoning Bylaw Passed

A revised Greensboro Zoning Bylaw was passed at Town Meeting by a vote of 87 yeas to 24 nays and is now in effect. It was posted on the Town website on March 6, 2014. Revision of the By-law began in November 2012 following passage of the latest Town Plan. Following an extensive series of working meetings, the Planning Commission held a meeting for summer residents in August 2013 to review the draft By-law. In response to both written and oral comments, a couple of key changes were made. Further changes were made following a meeting for Greensboro residents held in November of last year. Finally, the Select Board approved the revised By-law in January. The focus of the new document is on increased protection of the Caspian and Eligo lakeshores. However, there are also new sections dealing with waivers of By-law provisions and with agricultural industries in the Rural Lands District.An important section of the document includes four pages which contrast the important elements of the previous by-law and those of the new one. Interested parties should pay close attention to these changes.

In the meantime, the Vermont Legislature has been working for the past year on a new lakeshore protection law which would apply to ALL lakes in the state. We have received assurances from the Agency for Natural Resources that if the provisions of the law are not made any stricter than they are now, our revised Greensboro Bylaw will rule, and we will be allowed to administer it. At present, we are waiting for a final decision and will inform Association members as soon as it becomes available. *Phil Gray, Chair*

GAAR has reached a sales agreement with David Allen for 10 acres of Hazendale Farm including the current farmstand which will continue to operate this summer. In the future Hazendale Farm will operate at a new farmstand to be located next door.

Circus Smirkus Camp News

The proposal to build a children's summer camp on the Lonegren property on Breezy Avenue is close to passing it's last hurdle. Once the Act 250 ruling by the state is received, the project will be fully ready to proceed. Closing on the property is projected to take place April 2014. Caspian Open Water Swim Event

Kingdom Games is holding the *Swim the Kingdom* series, which includes open water swims of varying lengths in eight of the Northeast Kingdom's finest lakes. Caspian Lake is naturally once again a part of the series, and this year's swim will be on Sunday, August 17 at 9:00 AM. Last year's swim was a huge success with a total of fifteen swimmers up from five in 2012. Anyone renting or owning in Greensboro can register for the swim for \$50 this year, but to qualify for the reduced fee, each swimmer must be accompanied by his or her own kayaker. Caspian Lake Report

The Lake froze December 14, 2013, which is unusually early. In early February there was a week where the ice skaters had near perfect conditions. Water quality was average for Caspian all summer and fall. Water clarity was good, phosphorus and chlorophyll A levels were low and stable. There are no signs of Milfoil, zebra mussels or water chestnuts. However water temperatures rose to above average levels during August which created some issues with localized algae and a few instances of "green foam" on downwind shorelines. These cleared up as soon as the lake cooled in September.

Greensboro Association Inspectors checked 615 boats and trailers at the boat ramp last summer and found two carrying milfoil fragments. They were denied entrance to the lake and escorted to the wash station for a thorough cleaning. We have again applied for State of VT grants to support the cash costs of our Milfoil Prevention Program this year. The Town of Greensboro voted at Town Meeting to provide supplemental funding as well.

Support the Local Caspian Arts

Caspian Arts was formed in 2010 as part of the Vermont Crafts Council's statewide research project, 'State of Craft'. That summer, thirty artists exhibited their work in a cooperative gallery at The Miller's Thumb in Greensboro. Caspian Arts represents both fine and craft artists who live in approximately a 12 mile radius of Caspian Lake. We discovered that even though there are many artists in this area, they were relatively unknown. Caspian Arts aims to rectify this situation by providing marketing and promotional opportunities, both of which are particularly difficult for artists in rural areas. We actively seek gallery space around the state to host exhibitions, aid artists in creating professional promotional materials and educate our members in ways to utilize social media as a marketing tool. We maintain a website (http://www.caspianartsvt. com) which is linked to the Vermont Chamber of Commerce site and The Vermont Crafts Council. Each member has their own page with images, a description of work and information about how to locate the studio. Many of our members welcome visitors year-round. Our annual summer Studio Tour (Tuesday, July 29, 2014) has become an eagerly anticipated event. Visitors discover interesting out-of-the way places, shop for unique items, and get a peek into the workspace of artists



whose work they admire. The day ends with a festive party featuring a drawing giving away "Art Certificates" to be used in participating studios. Also look for our banner in the 4th of July parade and join the "buy local" movement by shopping at a *Caspian Arts* member's studio!
