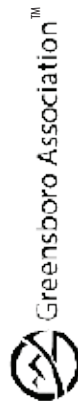

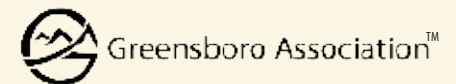

## What is THE FUND for Greensboro?

**THE FUND FOR GREENSBORO** provides opportunities for members of the Greensboro community to contribute to the long term health and character of the community we love. The mission of **THE FUND** is to invest in social, educational, municipal and environmental projects that are important to the Town of Greensboro and its people.

## What does THE FUND support?

**THE FUND** supports community initiatives that address emerging opportunities and challenges that might otherwise be passed over due to lack of funding. These initiatives include lake and environment protection, early, elementary and life-long education, town infrastructure, public health as well as community and economic development.

## How can I participate?

**THE FUND** offers donors flexibility. Gifts of cash, securities, real estate or other tangible assets are gratefully accepted. Gifts may be designated to **THE FUND** or to its two restricted sub-funds: *Community* and *Environment*.

- › **THE FUND FOR GREENSBORO** is the permanent philanthropic unrestricted umbrella fund that supports ongoing and emerging needs of the Greensboro community and its environment over the long term.
- › **COMMUNITY FUND** is restricted to support social, cultural, educational, and infrastructural needs of the Town of Greensboro and its surrounding community.
- › **ENVIRONMENT FUND** is restricted to protecting Caspian Lake and its surrounding environment. This fund supports education and habitat preservation as well as invasive species prevention and eradication.
