The Greensboro Association Annual Meeting August 1, 2024 Draft Minutes

This meeting convened at 4:00 at Turning Stone Farm, hosted by Jennifer Ranz. All Greensboro Association members were invited, of which an estimated 150 attended.

Cathy Irwin, President, opened the meeting. She noted this was the GA's 90th year. A summary of recent accomplishments included over \$250k in grants provided to area non-profits and emergency relief efforts over the last four years, thanks to generous donations to the Fund for Greensboro during the Covid-19 pandemic and following last year's major flood. Other GA activities include shoreline protection efforts, lake water quality monitoring, our annual support of the "Funky Fourth, the Tour du Greensboro Nordic ski event, the Bend picnic and block party, the community garden, summer sailing races, swimming lessons, and hosting the Caspian Challenge road race (with over 90 participants this year). In these activities and the FFG grants program the GA is an increasingly strong partner for the Town of Greensboro and surrounding communities.

Cathy also mentioned that this year the Board engaged in a strategic planning process that led to a new mission statement that positions the GA as an effective 'connector' between individuals, organizations, and town governance activities.

Mary White, Secretary, then called for a motion to approve the minutes from the 2023 Annual Meeting. The motion was seconded and the minutes approved without discussion.
